### The Challenge

These critical gaps in the ability to understand and meet regulatory obligations can lead to severe fines and penalties, as well as damage to the organization's brand and reputation.

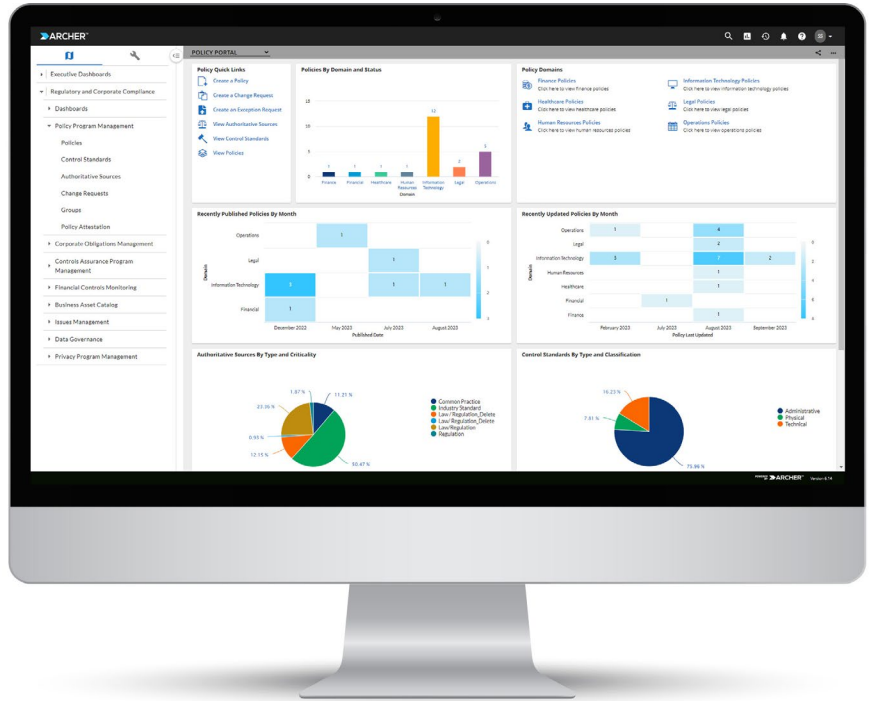
